- ***UnitedHealth Group signals potential exit from Obamacare exchanges amid financial losses***

UnitedHealth Group may exit the insurance exchange market, as the deterioration in product performance has weakened its financial outlook, the company said in an earnings update released Thursday and they have already pulled back on its marketing efforts for individual exchange products in 2016.

- ***CMS credits new payment models in averting \$19.8 billion in costs***

The Centers for Medicare and Medicaid Services (CMS) has reported that they have pledged to have 30 percent of Medicare payments tied to value by 2016; and 50 percent by 2018. As a result of their current changes from reimbursement for fee-for-service to one which rewards quality and value, there has been 87,000 fewer hospital-acquired condition related deaths from 2010 to 2014.

- ***Average silver plan premiums for HMOs and PPOs rise significantly***

Consumers seeking health policies with the most freedom in choosing doctors and hospitals are finding far fewer of those plans offered on the insurance marketplaces next year. And the premiums are rising faster than for other types of coverage. None of the plans available through the federal exchange in Houston include the city's well-known MD Anderson Cancer Center in their networks.
